locals, has sprung forth before in recent history. Remember folks, there's a lot of surprises under the streets of the Comstock. Dress accordingly.


In Chronicle news, I want

The Guinness Book of World Records

thrown an actual giraffe, but I'll bet my Golden Gloves that he might like to try if presented with a giraffe.



King's Corner

Have you ever seen a situation that seemed beyond healing, beyond any redemption, that suddenly turned around? This is a saga with a surprise ending.

Lillie grew up in a small town in rural Wisconsin and, in high school during the depression, got pregnant to a rich boy who didn't want to know. Young Marion grew up in Minneapolis and was an early teen when her mother married George, the villain of our story. He soon 'broke her in' and in those days there was little she could do except try to escape.

When my dad, Mark King, was discharged after victory in Berlin, he moved to St Paul MN to be near his mom and step-dad, Julia and Clarence. He hung out with his friends Meryl and Joey at a bar on St Peter's Street and the neighboring restaurant on the corner of 9th Street, Mother Merrills. Marion came in to MM one night with a friend, met Mark, then returned on her own several times. They started dating.

Merl and Mark were then away for four months combing wheat near Dodge City, Kansas. On their return Julia told Mark that, "You must have done something to make her think you are going to marry her" which was her roundabout way of saying he got her pregnant. Meryl said "We've been away four months and she's only two month's pregnant!" but Mark's mother made him feel guilty. They married. Soon after George fed her large doses of ergot and quinine which induced a miscarriage.

Fortunately George and Lil moved to California. Mark and Marion conceived Debbie. Marion went to visit her mom, then George wrote that she would not be returning. When

Mark came to their house in Chico CA, George's face was covered with scratches where Marion had fought him off. But he wouldn't allow her to leave, or see Mark, except when Debbie was born. Then George and Marion left for Southern California. George organized the divorce.

Mark made monthly child support payments for three years until all the checks were returned by a government lawyer, uncashed. The cover letter said they'd been declined by the mother out of belief that if she cashed them the father might have rights to see his child.

Does this sound to you like a disaster? No one knew if Lillie knew what was going on with her daughter and granddaughter. But a few years later, at George's funeral, she was the last to speak. She stood up at the podium, simply said "May he rot in Hell", and sat down again. Marion never told her daughter Debbie about George's role; she simply said that Mark was never there for her as Debbie grew up.

In those days divorce took many years. Mark met someone else in the meantime and another baby was on the way. But his divorce would not be final in time for them to marry before I was born. So my mom put me up for adoption and I grew up elsewhere.

How unjust does all this feel? Mark didn't see his children grow up. Debbie was led to believe the worst about him, and I didn't know anything about him for over twenty years.

And you've been patient to read this far. Would you say this felt irredeemable? That George chose to destroy several lives and got away with it? That God's wheels of justice were barely

turning, if at all? Who could blame Mark for feeling that nothing about this was fair? But he chose to move on with life, and embrace it wholeheartedly.

Then the tide turned.

I found my birth mother, we had a wonderful lunch with my birth father, and I learned I had an older half-sister. I met Debbie at her home one evening, with her husband Mike and their three young kids. She and I immediately connected, and there was no mistaking we were siblings. Mike sat silent most the night, so I asked if he was all right. He said, "Maybe. This is like watching a male version of my wife, and I'm not yet sure how I feel about that."

We exchanged vastly different stories about our father. Over time we listened to each other, but could barely believe we were talking about the same person. I told her I'd found the lawyer's letter with all the uncashed checks, but her mother Marion denied it all.

Then Marion was diagnosed with cancer. Three weeks before she died she said to Debbie, "You know all those things your brother has been telling you about your father? They're all

true, and everything I told you was a lie. Please forgive me." Then she was gone.

We met at Mark's home here in Stagecoach. Debbie & Michael drove down from Oregon, and I flew up from Australia. We were all together, but it was hard for Debbie. I laid out the lawyer's letter and checks from almost fifty years ago to show he'd always fought to be in her life. At first she could barely touch them. Then healing happened. Before they drove away we had genuine family time together.

Later, when Debbie had the same cancer as her mom, she and Mark sat holding hands and talking up until just before she passed. Complete reconciliation.

Why this story? No situation is beyond hope. God's wheels of justice may grind slowly, but they grind very fine. Sometimes results are here, sometimes in heaven, but you are never overlooked or unloved. There may be a George in your life, but there's also God, and he's always there for you. To bring you healing, and hope, and justice, and reconciliation. Ask him, and trust.







Water Main Break Resolved

A water main break at the intersection of D Street and Union Street was successfully turned off earlier this week, according to local authorities. Crews responded promptly to the incident, and no residential areas were impacted.

Two businesses, the Bucket of Blood Saloon and The Lost Seoul Saloon, experienced temporary disruptions due to the break. No boil water order was

issued, and officials confirmed that water main flooding was not a concern, despite storm flash flood advisories that were in effect at the time.

Sand and sandbags were made available at VC Icehouse, located at 110 Toll Road, to assist with any potential runoff concerns. Authorities reported that the situation was fully resolved with no further issues expected.

Friends of Sutro Tunnel receives NV Energy Award

The Friends of Sutro Tunnel Charity received a 2024 Cycle 2 award from the Nevada Energy Foundation in the amount of \$5,000. The Foundation funded the Charity's Youth Historic Restoration Service-Learning Project. The project focuses on restoring the Carriage House carriage door as well as installing a youth-designed and created history overview board on a topic related to Adolph Sutro and the Historic Sutro Tunnel and Site to be displayed in the Carriage House near the entry of the Historic Sutro Tunnel and Site.

The goals of the project include increasing public access to the Carriage House and inspiring young people to become interested in Nevada history through hands-on involvement in a restoration project. The project will conclude with a Celebration to recognize the youth group as well as Nevada Energy Foundation. Through the success of this project, the Charity hopes to involve more youth to be involved in restoration through an ongoing Living History Services Learning program and offer a NV Energy Founda-

tion Acknowledgement scholarship for youth to participate.

Through a Scouting America Troop, the Charity recruited a 17-year-old youth to lead the project. As part of the process of earning an Eagle Scout rank, the youth has been working with his troop to finalize details. Upon approval from his council, the youth moves into the implementation phase and leads a group of fellow scouts, alongside a carpenter mentor, to build and install the carriage door based on a design approved by the

Comstock Historic District.



Pamela Abercrombie, Sutro grant writer and volunteer lead said "I'm excited about this project because it will inspire youth with an interest in our rich Nevada mining history and expose them to the fun embedded in historic preservation! Skeleton Skin Tattoo

If you have driven through Mound House and noticed the towering skeleton and black hearse parked on the north side of Hwy 50, then you know Skeleton Skin Tattoo. The eye-catching display is not just a clever marketing move; it is a reflection of the creative, unconventional spirit of shop owners Josh Thornton and Heather Conka-Thornton, who have been making their mark on our community and the tattoo world for more than 15 years.

The couple's path into tattooing wasn't exactly planned.

"I tattooed a handful in high school and [screwed them] all up then quit 'cuz I didn't know what I was doing," Josh admitted with a laugh.

Heather, on the other hand, was deeply involved in the local art scene. She was experienced in creating wood-burned and mixed media pieces, winning awards at the Brewery Arts Center. A friend from L.A. recognized their artistic potential and flew out to get them started with a crash-course apprenticeship in 2007.

"We just tattooed 24/7 for that entire time," Josh recalled.

It did not take long for their talents to be recognized. Within their first two years, they entered into a contest "just for funzies" at their very first tattoo convention and walked away with first place.

The duo jumped straight into

running their own shop – they spent the first year in Carson City, but this month marks 15 years of Skeleton Skin Tattoo in Mound House.

"Once we got up here, we realized that we really liked it because, you know, Mound House is weird and so are we. Keep Mound House weird," Josh chuckled.

Two other artists – Erik and Jace – are also part of the Skeleton Skin family. Erik has been with the shop for 13 years and Jace joined them about one year ago.

Inside the shop, Josh and Heather specialize in different styles. Josh leans toward colorful, cartoonish tattoos, while Heather has earned national recognition for her realistic portraits. She has also used lights and mirrors to tattoo most of her own ink.

"She's won awards all over the country for portraits and realism," Josh explained. "We've done conventions all over the place."

One of Josh's most memora-

ble projects even landed him in Guinness World Records. In 2020, he was the canvas for 420 black ant tattoos completed by five artists in three hours.

"I have a lot of bug tattoos already, bugs I played with as a kid – pinchers, roly-polies," Josh explained. "I always wanted to do an ant trail because I used to play with the plastic ants as a kid, the little crank ones."

The tattoo marathon was timed to coincide with Reno's Zombie Crawl and served as a tribute to Zombie Boy, the heavily tattooed artist who had previously held the record.

When they are not in the shop, the twosome are engaged in disc golf, outdoor activities and other unique hobbies, like ghost hunting (commonplace on the Comstock!). What started as fun with friends turned into regular involvement in paranormal investigations. They have become leads with Northern Nevada Ghost Hunters (NNGH) but also look for opportunities further afield, including Carson Prison and the famously haunted RMS Queen Mary.

"The way I explain ghost hunting, it's like fishing. You can go fishing all day and not catch anything. But once you catch that big one, you're like, 'Oh. I want to do that again,'" Josh said.

Lyon County Board of County Commissioners Meeting Summary

The Lyon County Board of County Commissioners (BOCC) met on Thursday, August 21, 2025 to hear presentations and take action on several significant agenda items. Highlights from the meeting include:

Historic Dayton Depot Restoration Project

The Board heard a presentation from the Dayton Historic Society regarding the reconstruction of the historic Dayton Depot building, which was destroyed from a fire that was set in June 2020. The Society outlined plans to return the structure to its historic characteristics and highlighted the importance of getting the rail depot back on the register of historic buildings. Following the presentation, the Board discussed adding future improvements to the site such as onsite restrooms and fire sprinklers as funding opportunities are available in the future. The Board voted to direct County staff to move

forward with construction on the project.

Lyon County Housing Assessment & Affordability Analysis

The Board of County Commissioners heard a presentation from the University of Nevada, Reno (UNR) Nevada Economic Assessment Project's (NEAP) Housing Assessment and Affordability Analysis for Lyon County. This report will inform policy, grant applications, strategic plans, and programmatic solutions as appropriate to address the attainable housing gaps and needs for our residents. The full report is available on the NEAP Rural Housing web page.

Awards & Recognitions

- Commissioners recognized the retirement of the Lyon County Sheriff's Office K-9 Borys for 8 years of service with his dedicated handler Sergeant Wayne Hawley. Commissioners presented the

volunteer group, Desert Pigs, with the Good Samaritan Award.

Other Board Actions:

- Park Construction Tax – Approved a request from the City of Yerington to use park construction tax in the amount of \$33,973.01 for improvements for tennis and pickle ball courts on East Goldfield Avenue.
- Tradition Village 2 Subdivision Map – Approved the request submitted by Lucas Homes and Development LLC to amend Condition 20.g of the Tentative Subdivision Map originally approved on May 2, 2019 (PLZ2025-055) to allow infrastructure and housing to begin without delay for Tradition Village 2 Phase 1. Drainage improvements remain required and enforceable prior to the broader build out of the project.
- Pretrial Services Department – Approved reorganizing and renaming the Court Services Department to report to the County Manager or his designee instead of to the Justice Courts and to rename the department Pretrial Services Department.
- Planning Commission – The Board acknowledged the resignation of Ralph N. Ewing from the Planning Commission. 
