

King's Corner

Traveling by air from South Australia to Reno usually takes around a full day if you make all your connections, longer if you don't. This became an annual ritual as I lived down under while my dad, Mark King, and step-mom Luanne lived here. Then came COVID-19 and instead of several flights daily there was just one, and you could only board with special permission from the tightly-locked-island-continent's government. Never did distance seem so vast.

Yet at the bottom of the world life went on as normal. I started a new job on a six month contract that promised to extend into long term employment. I tackled a major challenge, designing the move of the state electricity provider's systems and data into a newly-configured version of "the cloud", that vague phrase that describes an oversized cluster of computers almost no one will ever actually see. Life amid the distant crisis was going well, with a promising future.

Work took me out for a meal, a celebration of the challenging phase we'd just finished weeks ahead of the deadline that no one thought was even achievable. They let me know how much they appreciated my work, but someone else would be carrying that project forward. I was suddenly done, and a month early.

God, what just happened? All my plans had just been turned upside-down. It seemed very unfair. Yet life is often not fair.

Each of us could tell stories of life taking unforeseen turns, sometimes taking a terrible toll.

What do you do when God says "No"?

I would suggest that the first thing you do is this: You recognise that God saying "No" is just as much a demonstration of his love as his saying "Yes."

There was a time when I worked with difficult boys. They were as different as day and night. But there was one common factor that seemed to appear in them all. And while they were not sophisticated enough to grasp this being so, this was very obvious to one looking at it objectively.

They all said that they had not been loved by their parents. And they all advanced - as the illustration of that lovelessness - the fact that their parents never disciplined them. Never said "No" to them. It would come out like this:

"My parents didn't care about me. They didn't care when I came in at night."

"My parents didn't care about me. They didn't care what I ate, or whether I ate or not."

Expressions, you see, of lack of discipline. You know how it is if you have a dog that you don't care anything about at all, you'll let that dog run where it wants to run, eat what it wants to eat - you'll take no care of that dog. But if you really are concerned for the dog, you discipline it. You train it. You do the things which are necessary to make that

dog into everything which that dog has the capability of being. Your "No"s to that dog are just as much expressions of caring as your "Yes"s.

Any parent understands that in the moment when he or she says "No" to a child, they might be demonstrating a deeper love than any number of "Yes"s they might utter. And it's important that we grasp that when we're talking about the "No"s of God.

Now here's another thing to remember: God says "No" because he has a better idea.

In Nevada my dad had an accident the year before where he lost most of his sight. My step-mom was fighting cancer and was about to have a risky operation. Over the distance I could offer concern and consolation, but little more during the worldwide lockdown. Then from the hospital I received the news she had not survived the operation. Suddenly dad was on his own, and needed help.

And that job I'd been so heavily committed to had just suddenly - unexpectedly - finished three days before. I was available.

"He never closes a door with-

out opening a window."

It was Helen Keller who said that. She was blind, and she was deaf, and she was dumb. Now none of us have ever heard the "No"s of God like that. But it was Helen Keller who said,

"He never closes a door without opening a window"

In Australia during the COVID crisis no one could enter or leave without government permission, granted for only extraordinary reasons. But they were responsive to my story of my dad's plight, and a few days later I had a ticket on the only flight out.

My dad and I then had the best year-and-a-half of our lives together, a precious and often hilarious time when he finished out his 96 years actively, until one night he kept sleeping. A time I might have missed if God hadn't closed a door but opened a window.

I can sum it in a single sentence, but it's taken me my whole life to learn the sentence: Some of the loveliest things God has ever said to me began with the words, "My beloved child, No."

The Lyon County Commissioners unanimously approved the reconstruction of the Dayton Depot. On August 21, during the Lyon County Board of Commissioners meeting in Yerington, the board voted 5-0 to move forward with rebuilding the historic 1881 Carson and Colorado Railroad Dayton Depot and to sign the contract with the winning bidder. Dayton residents welcomed the decision.

Originally moved from Mound House to Dayton's Railroad Street in 1881, the Depot was later relocated to a vacant lot at the corner of US 50 and Main Street, where it was remodeled into a residence around 1955. Over time, owners Chester and Helen Barton, along with members of the Historical Society of Dayton Valley (HSDV), recognized its significance to Nevada's railroading history and worked to preserve it. Tennant Construction and Marty Banta Construction used house-mov-

ing equipment to relocate the Depot, and volunteers diligently restored it to near completion—until an arsonist set it ablaze.

Speaking for the HSDV at

the Commissioners' meeting, Stony Tennant, a longtime local contractor and historian who dedicated countless hours to the Depot's reconstruction, explained that fire insurance would cover the rebuilding costs. Once completed, the HSDV could pursue grants for additional features. Tennant emphasized the importance of restoring the Depot to its original 1881 appearance and noted that it would not be fully operational until restrooms, electricity, and fire suppression systems are installed. He thanked John Crowley and Dr. Linda Clements for their committee work in advancing the project.

Lyon County Commissioner John Cassinelli expressed enthusiasm for the reconstruction, stating, "I look forward to rebuilding the Dayton Depot

and securing its place on the National Register of Historic Places. The Carson & Colorado Railroad Depot is a vital part of Dayton's and the region's history. As we develop this area into a historical tourism destination—alongside sites like the Sutro Tunnel and Donovan Mill—the Depot holds great potential as a starting point for self-guided tours and future site improvements, including parking and restrooms. Some have raised concerns about the lack of fire sprinklers, which I understand, but the building is only 20' x 60' (1,200 sq. ft.). Commercial fire sprinklers are typically required for structures over 5,000 sq. ft. The Depot will be a simple, square-set timber warehouse-like structure, used to store historic artifacts and serve as a satellite museum."

Main Street Will Roar to Life During Dayton Valley Days Show-n-Shine

One of the biggest highlights of Dayton Valley Days each year is the Show-n-Shine, where polished chrome, rumbling engines, and proud owners line Main Street in Old Town Dayton to show off their rides. This year's show on Saturday, Sept 20, is shaping up to be one of the biggest and most inclusive yet, thanks to a new partnership between the Good Nuff Stuff Car Club and title sponsor NPC Automotive.

Ray Ramirez, president of Good Nuff Stuff, has been leading the club's efforts to keep the Show-n-Shine one of the area's most anticipated events as well as build a like-minded community of car and motorcycle enthusiasts.

Cherrybomb Betties Tiki Pinup Contest is scheduled for 12pm. Whether you're showing a car or just coming to enjoy the view, you'll be part of a tradition that celebrates horsepower, history, and hometown pride.

"It's just about giving back to the community and being a part of the community," Bircheff said. "We want to encourage people to come out and support local business more than anything. Coming to the car show and being part of the show supports us and also supports the hundreds of other vendors that are going to be there."

The Dayton area is growing before our eyes. With hundreds of homes and new shops planned for the coming years, current business owners would be wise to start planning for increased foot traffic. Hazel and Shane Koch recognized that change is coming and decided to create a new business that would fill a void and help their neighbors. Dayton Pack and Post officially opened its doors last Friday, Aug. 29 at 9 Retail Rd. #6, near Smith's.

The idea for the business was born not in a boardroom or during a market analysis but right in the Koch's living room last Christmas.

"My husband has a lot of business at Christmas time, it's always a busy time of year for us," Hazel explained. "We have about 50 clients that we send care packages so for packaging, my whole living room is a mess."

The duo also noted that anytime they had to ship through UPS, FedEx, DHL and Amazon, they were having to trek into Carson City to handle it. With Shane's attention to detail, their experience in customer service and our growing community needing reliable shipping methods, the Kochs knew they could serve Dayton in a bigger way.

"So I told him, 'You know what? We should turn your knack of careful organization and customer care into a business.' So that's really when Dayton Pack and Post started," Hazel remembered.

By April 2025, the Kochs were signing their first lease. Less than a year after the initial idea, the couple is now welcoming customers into their storefront. And they have accomplished this while working full time jobs.

Dayton Pack and Post will offer FedEx services starting Sept. 5 and is in the process of finalizing contracts with UPS and DHL. They will also be able to accept Amazon returns with labels in the near future, but for now, their partners at Louie's Ace Home Center in Dayton is still accepting Amazon returns. Note: If your returns require a QR code, you will still need to take those packages to UPS.

"It's coming together, but there's still some tweaking that needs to be done," Hazel said.

The business is not just about shipping. Dayton Pack and Post is designed to be a one-stop resource for the community. They have more than 750 mailboxes for rent, eco-friendly packing materials, supplies, stamps, greeting cards, computer rental and basic printing, plus Hazel plans to offer notary services soon.

"My goal is to offer more personalized service for locals... hopefully a welcoming storefront and focus on community connections and community service," Hazel clarified. "We envisioned a store that not only ships packages but builds trust, making every customer feel like a priority because they are."

For September, the business is rolling out an introductory promotion.

"All new customers are going to have a lifetime discount \$25 off their annual mailbox rental. That also comes with free copies, free notary, free faxing... I can also save their packages, especially when they're on vacation for a week," Hazel said.

Mailboxes can be rented for three, six, or twelve months, with the best value at the yearly rate. Hazel also hopes to expand into virtual mailbox services in the future.

The store is a true family-powered business – the couple's three kids will be pitching in to cover shifts until they are able to hire a few more people to assist the two employees they currently have helping them hit the ground running.

From a spark of inspiration during a hectic holiday season to a grand opening less than a year later, Dayton Pack and Post represents the determination of a family who saw a need in their community and decided to fill it.

As Hazel summed it up, "We are ready to act, driven by God's grace and driven by a belief that a business built on care, reliability, and hard work can flourish."

Dayton Pack and Post will be open Monday-Friday 8:30 a.m.-6 p.m. and Saturday 9 a.m.-4 p.m., closed on Sunday.



The Camel Barn on Pike Street in Dayton - A Treasured Nevada Landmark

Believe it or not, once again, visitors from all walks of life and places are heading for Virginia City to see the 66th annual Camel races that now includes ostriches. For Daytonites and other Nevada historians, it's also a time when Dayton played a role in this unique phenomenon of bringing camels to active mining and milling at Nevada or Sacramento sites that dates to the mid-1850s into the 1860s.

Camels were first imported to the United States for military purposes in the mid 1850s, when Lt. Edward Beal, with the US Army, evaluated the animals for possible caravan operations in the southwest deserts. The experiment was not successful and the camels were auctioned off. Some were brought into this area to haul wood from nearby mountains or salt from the flats east of Fallon to the mines and mills of the Comstock, including

Virginia City.

Since Dayton's Pike Street was located on the original California Trail, and those in charge of moving the camels to Virginia City, or even to Sacramento, often needed a place to feed and bed the animals, the camels were often corralled behind a large stone building, known as the Leslie Hay Barn built in 1861 by George Leslie and in later years and today as 'Leslie's Camel Barn.' This historic barn remains today on Pike Street along with the Nevada State historical marker, 'number 199,' thanks to the pioneer Leslie family who settled, built the barn and adjacent corrals, including the substantial rock barn and a smaller barn made with wood also existed. This barn was torn down in the 1960s.

Lillie Ann Leslie has written a little history of the family's first arrival to Dayton from Salt

Lake City, noting the Leslie's, her father, George and mother, Ann Howard Leslie, traveled on a wagon train in 1861 when she was six years old. One of her memories include being visited by a group of friendly Indians. Evidently, the Chief was bewitched by her charm and beauty and 'a wealth of auburn hair' and he also offered a great many ponies for her." She noted that the wood industry was essential for operating the mills since steam was the power source then.

Lillie Ann said, "In 1861, George Leslie, my husband's grandfather, built the stone barn, which still stands, along with extensive corrals. The stone used for constructing the barn was taken from a quarry owned by him. The quarry was situated near the Rock Point Mill. The stalls were added later and the corrals were filled every night.

The great freight wagons were an interesting sight. The camel trains were a delight to young and old alike. The camels could carry large loads of salt that was used in the reduction of the ores. There were always several camels in a lead caravan wearing bells. The drivers were turbaned Arabs. The bells could be heard from a great distance and upon hearing the bells, the cry rang out to see the caravans, the cry rang out along the streets.

'The camels are coming and the children ran out to see the caravans come in.' Mr. Leslie built special corals for the camels as they frightened the horses and mules. Finally, laws were passed that permitted the camel trains to pass through towns only at night."

The pioneer Leslie family arrived in Dayton in 1862

George Alexander Leslie family ancestors were Scotch and his wife, Ann Howard Leslie, of Newton moor, Cheshire, England arrived in Dayton in 1862, coming to Utah, where George had furnished supplies for the US Army there then. He had assessed a store at Camp Floyd, another at Ft. Lehigh, two grain mills, stock and land. When he left the area, he had accumulated numerous items, including two large horse pulled trailers loaded with grain and his wife and three children, George, Lillie and their baby, Minnie May. Belle Leslie was born later in Dayton.

George had planned to leave Utah Territory for California but when he reached Dayton on the Carson River, there was a placer gold boom on Gold Creek that ran through Dayton. The family camped exactly where, years later, the Carson and Colorado RR Depot was built. Before long, George bought four blocks of land and built a substantial home. An office and stables entirely enclosed one



Civil War Days in VC

Over Labor Day weekend, Virginia City celebrated its rich history with events that transported visitors back to life on the Comstock in the 1860s. During the American Civil War, Union sympathizers played a key role in pushing for Nevada's statehood so the territory could participate in the 1864 presidential election in support of Abraham Lincoln. Their efforts paid off – Nevada became the 36th state in 1864.

Although only about 1,200 Nevadans fought for the Union, the state's greatest contribution came from the silver of the Comstock Lode, which helped finance the war. Nevada also served as home to several Union military posts, further cementing its importance to the cause.

This year's celebration, organized by the Comstock Civil

War Reenactors, featured Battle Trains on the V&T Railroad, demonstrating the dangers of riding the rails while valuables while prisoners were on board. Guests could explore the living history camp at Miner's Park, showing the struggles of daily life for both civilians and soldiers. On Sunday afternoon, the camp hosted a lovely high tea, with delicate snacks and fine teas, followed by a beautiful Heritage Ball at Piper's Opera House that night. More than 40 couples attended, learning the Grand March and other formal dances. It was a lovely evening, and the formal wear was spectacular.

Monday's festivities brought high drama with a staged robbery at the Delta Saloon. The

block that included a large hay and grain barn and an immense stone barn, which is still a landmark in Dayton.

An interesting story of the barn occurred when Grant and Seymour were running for the office of the US presidency and a bet was made between them. One posted \$2,000 in gold coins he'd win and the other, \$2500.00 in ranchers' grain, stored at the Camel Barn. The rancher lost

and the children enjoyed playing there until the sacks of grain were moved higher up in the barn.

The information on the history of the Leslie family was published in the Nevada State Journal in 1939 by Mrs. Thurlow Douglas and sponsored by the Sagebrush Chapter of the Daughters of the American Revolution in a series on Nevada Pioneer Families.

Attempted Murder and Arson in Dayton

On August 31, 2025, at approximately 1647 hours, Lyon County Dispatch received a 911 call from a female subject, who advised a male subject (later identified as ALBERT BUHER) was screaming at her, took her camp fuel, threatened to burn her camp down and attacked her. The reporting party advised BUHER eventually left her camp and returned to his camp.

Lyon County Sheriff's Office Deputies responded to the campsite, located near a water tower above Cemetery Road in Dayton, Nevada. As Deputies responded, the reporting party called Dispatch again, advising there was a trailer possibly on fire. From Highway 50, responding Deputies observed black smoke coming from the area of the campsite.

Upon arrival, Deputies met with multiple witnesses, who advised they observed BUHER place fuel on his trailer, and observed a fire start shortly after. There were numerous other trailers and vehicles in the immediate area, which also caught fire, resulting in a total loss of many of them. Deputies also learned that BUHER had battered two different individuals and made threats to kill them.

Witnesses advised BUHER had fled from the campsite prior to law enforcement's arrival. Deputies searched the area for BUHER, who was later located at a local Dayton business and taken into custody without incident.

BUHER was subsequently booked into the Lyon County Jail on the following charges:

- Attempted Murder (Felony)
- 1st Degree Arson (7 Counts) (Felony)
- 3rd Degree Arson (5 Counts) (Felony)
- Domestic Battery (3rd offense within seven years) (With intent to Kill) (Felony)
- Reckless Endangerment (Gross Misdemeanor)
- Harassment (2 Counts) (Misdemeanor)
- Simple Battery (Misdemeanor)


