



Sunday, Oct. 26 marked 150 years since the Great Fire of 1875 in Virginia City, one of the most devastating events in the town's storied history. Locals and visitors gathered in the Bucket of Blood/Delta Saloon parking lot to to remember the tragedy and honor the resilience of those who lived through it.

The Great Fire broke out around 5:30 a.m. at an A Street boardinghouse and raged for nearly nine hours, fueled by strong winds and dry timber. The flames eventually fizzled out around 2:30 p.m, destroying more than 2,000 homes and businesses, causing an estimated \$20 million in losses to the Comstock — the equivalent of more than \$525 million today.

Despite the immense destruction, only two deaths were directly attributed to the blaze (a third victim later succumbed to injuries from the fire). The impact reached far beyond the Comstock.

"The impact was felt throughout the U.S. as the market was so heavily impacted by the concern for the mines in the area," noted Storey County Fire Protection District on their Facebook page.

Local historian Joe Curtis addressed the crowd during the commemoration, reflecting on both the devastation and the determination that followed. "So we're back here today, in 2025, recognizing what these guys did to try to save this community and then help it to come back to what it is today."

Curtis noted that remnants

of the fire still exist beneath the surface. Residents living on the lower end of town – once the industrial district – can find historical artifacts buried on their properties from debris hauled down the hill after the fire as the community began to rebuild. Within just a year or two, nearly all of Virginia City's iconic structures had been reconstructed, marking the town's incredible recovery.


Today, you can stop by the Virginia City Visitor's Center to pickup a "Great Fire of 1875 Visitor Card", which showcases landmarks impacted by the fire and encourages guests to visit each location and learn more about area history.

For those interested in fire-fighting during the Comstock Lode era, Steve Frady's book Red Shirts and Leather Helmets offers an in-depth look at the history and heroism of those who faced the flames.

Long before HOA complaints and Facebook arguments, Dayton had its own "Nextdoor Drama."

It all started across the Carson River, where the hardworking Cassinelli family farmed their land and irrigated crops the old-fashioned way by moving a few boards in the ditch to share the flow. Well, one neighbor didn't see it that way. Rumor has it, she believed the Cassinelli's were "stealing her water."

Now, in most towns, that's grounds for a stern letter. But in 1904 Dayton? It was grounds for a shotgun blast.

Pietro Cassinelli was tending his irrigation when BOOM! he caught some pellets in the back from an irritated neighbor named Carmelinda Venturi. Don't worry, Pietro survived (and probably had the best "You think you're having a bad day?" story in town).

Carmelinda, meanwhile, got

herself arrested and was locked up upstairs in the Odeon Hall · yes, our very own building! Turns out the Odeon wasn't just for dancing, drinking, and live music... it was also the "temporary women's jail."

Now here's where it gets very Dayton: When the sheriff realized Carmelinda was pregnant and caring for a baby, the town basically shrugged and said, "Well, guess she's had a rough week · let her go."

And that's exactly what happened. She went home, Pietro healed up, and the two families stayed neighbors for decades proof that Dayton folks can feud hard, forgive fast, and still show up to church together the next Sunday.

So next time you're enjoying a drink at the Odeon, raise a glass to the Cassinelli's, a family that helped build Dayton's history, one irrigation ditch (and wild story) at a time.

# Dayton Valley Lions Club

The Dayton Valley Lions
Club was chartered in 2000 and
has continuously served Dayton,
Stagecoach, Virginia City and
everywhere in between. This
year marks 25 years of helping
with local projects, leading
fundraisers, and providing much
needed services and resources to community members.
Leading the club is longtime
member Jack Epperson, who has
dedicated two decades to the
organization.

Epperson has worn many hats within the Lions Club, from our local chapter to international leadership. He became president of the Dayton Valley Lions his second year with the club. From there, he moved up to zone chair, region chair, then district governor where he was responsible for all 45 clubs in Nevada. In 2014, he was elected to the

Lions Club International Board for a two-year term. Epperson was only the second person from Nevada to be an international director.

"When I came back [to Dayton], the club was a little sluggish at that point ... that's when I became president (again) and we rebuilt the club," he remembered.

Today, one of the Lions' main projects is sight preservation work. The Dayton club has more certified vision screeners than any other in the district, now at 50 clubs strong.

"Back in 1925, Helen Keller was at our international convention and challenged the Lions to be 'Knights of the Blind in the Crusade against Darkness', so the Lions accepted that challenge and we've been associated

with sight preservation ever since," Epperson explained.

Club members conduct vision screenings in schools and at local events, referring them to eye care specialists whenever necessary. In fact, they just started screenings with four Storey County schools earlier this

month and want to continue to expand their reach. Last year, the Dayton club taught Carson City Lions how to conduct screenings, which has helped more than 1,200 students in the neighboring capital.

"If the person that we refer is uninsured or under-insured, we'll take care of it," Epperson noted. "Then we will provide both the exam and the eyeglasses."

The club also collects used eyeglasses, sending them to recycling centers for redistribution to countries like India, the Philippines, and South America. Local Dayton drop boxes include Dayton Family Vision, Stor-All and Frugoli Family Dentistry.

Beyond sight preservation, the club is deeply involved in a wide range of community efforts, with partnerships playing a key role in their success. The Lions provide fans to local senior centers, host quarterly food drives in collaboration with the Healthy Communities Coalition and Grocery Outlet, and most recently partnered


## Stolen 1955 Pickup Recovered, Suspect Arrested

On the morning of October 8, 2025, a 1955 Ford truck and Polaris quad were stolen from the house of a recently deceased resident of Virginia City. Storey County Sheriff's Office Detectives identified a suspect and conducted surveillance on his movements.

On October 24, 2025 Storey County Sheriff's Office Detectives began visiting recent locations the suspect had been at. While on scene at one location in Lyon County, information was obtained that lead to the discovery of the stolen truck. The truck was located inside of a storage warehouse near the bottom of Six Mile Canyon Road in Lyon County, Nevada.

Storey County Sheriff's Office Detectives worked with the Lyon County Sheriff's Office and were able to successfully recover the truck. The suspect, identified as Wayne Wofford, was arrested by Lyon County Sheriff's Office for possession of

with the Knights of Columbus to support the Coats for Kids program. They also contributed to the development of the Dayton Valley Dog Park, support free yoga classes at the Dayton Branch Library, and donated funds for both the kitchen and playground at the Dayton Boys & Girls Clubhouse—along with installing the new flagpole onsite. In addition, the club donates gift cards to Central Lyon Fire to help families in need

after a house fire. And that's just the short list.




