Storey County to Host Lockwood Flood Evacuation Drill on Dec. 13

Storey County Emergency Management, in partnership with local first responders, will host a Lockwood Flood Evacuation Drill on Saturday, Dec. 13, 2025, from 8 a.m. to 12 p.m. The drill will allow residents to practice evacuation procedures and test emergency alert systems in a safe, controlled environment.

Residents are encouraged to participate as if it were a real flood. Smart911 alerts will be sent on Friday, Dec. 12, 2025, and again on the morning of the drill, providing directions and

updates.

Social media updates will also be posted on Facebook, Instagram, and X throughout the drill. Participants do not need to bring pets or livestock.

After the drill, residents are invited to a resource fair at the Lockwood Senior Community Center (800 Peri Ranch Rd) to connect with local organizations and learn more about flood preparedness.

Somewhat amused at what I could see was happening, I thought I'd have some fun, and double down on this abnormality. I knew the



last line of my newscast would be, "And the score of last night's football game was Baldwin 21, Maui High 17." So I started talking to my now attentive friend about last night's football game, then chimed in with the same words on the radio, "And the score of last night's football game was Baldwin 21, Maui High 17."

My surfer friend took a long last look at his Waikapu Whacko, tucked it between his thumb and forefinger, and flicked it unceremoniously onto the road. I doubt that he ever smoked again, so I like to take credit for reforming a young Maui surfer in my first act as a performance artist. I wonder sometimes what that young surfer might be doing today.

King's Corner

Cowboys in the Old West didn't have therapists, bullet journals, or apps reminding them to drink water and "practice gratitude." They had long days, stubborn cattle, bad coffee, and enough silence to make a person hear thoughts they didn't know they had.

And when life got too loud—when the bunkhouse bickering got old, the problems stacked up like wet laundry after a rainstorm, or a man's mind felt like a herd of wild horses—the old-timers had one simple prescription: "Go to the line shack."

A line shack was a crooked cabin on the far edge of the ranch—too remote for company and too small for comfort. Cowboys lived there while riding fence, patching breaks, keeping predators honest, and wondering why they ever thought ranching was sensible. It wasn't cozy or convenient. But it was quiet—the kind of quiet where even the loudest worries finally settle down. And when everything else in life is shouting, silence can sound a lot like God clearing His throat so He can talk.

My dad understood that kind of silence. He never "processed his emotions." He followed the cowboy method: feel something, ignore it, then fix a fence until the feeling either toughened up or wandered off. But life has a way of cornering a man, and it did that to him one unforgettable winter.

At thirteen, he left home and

drifted around the West: harvesting wheat, herding cattle, teaching tourists that horses do not come with brake pedals. But the job that shaped him most was a line-shack assignment so isolated even the coyotes looked lonesome. Six months in one cabin, riding fence every day with zero neighbors and supplies arriving every three weeks.

On his way to the cabin, he passed a school tossing out old textbooks. Dad bought the stack, nearly collapsed his horse, and rode off looking like the West's smallest mobile library. Then winter came with enthusiasm. The snow didn't just fall—it attacked. Some mornings he dug a tunnel from the door to daylight. Other mornings he hammered frozen wire with fingers so numb he could've autographed cakes.

But between storms, he read. Kipling. Shakespeare. History. Whatever the supply riders brought. And the King James Bible—partly because it was thick, partly because when you're alone in a frozen wilderness it helps to talk to Someone who understands wide-open country. Most evenings he sat by the fire, told God about the day, then listened long enough to notice steadying thoughts he knew weren't entirely his own.

By spring, he hadn't just survived; he'd been shaped. Later, when the Army tested him, they said, "Congratulations—you've completed high school and half of college by accident." Not bad for a ranch hand, a

pile of books, and a winter that refused to quit.

We don't get snowed into cabins anymore—the closest we come is when the Wi-Fi goes out—but life still gets too loud. Too crowded. Too fast. Our schedules overflow, our nerves fray, and our souls get tangled like barbed wire in a windstorm. That's when an old cowboy would shrug and say, "Friend, you need the line shack." Not as an escape, but a reset—a place to hear yourself think, to talk honestly with God, to sit in enough stillness that you can finally hear Him answer.

Most of us don't have a backrange cabin, but we do have moments, and moments can be line shacks if we guard them. A line shack can look like a quiet cup of coffee before the house wakes up, a walk with no earbuds, five unrushed minutes in your truck, a simple prayer whispered with your eyes closed, reading something that settles you instead of rattling you, or sitting still long enough for a little wisdom to rise.

A line shack isn't an escape from responsibility. It's preparation for it. It's where you check the fences inside you—whether they're sagging, broken, or letting trouble slip through. It's where you mend what's loose, unburden what's heavy, and let God do some of His quietest, clearest work.

So let me ask you—cowboy simple: When's the last time you went to your line shack? Not the literal one—unless you own a tiny cabin with questionable structural integrity—but that quiet place where you talk with God, listen for His steady whisper, and let your soul breathe the way it's been waiting to.

My dad always said he had "plenty of time to talk with God up there," and he said it with a grin that hinted those conversations changed more than the weather. So find your line shack, step into the quiet, tell God what's on your heart, and listen until something true rises.

Then ride back into your life with your head clear, your courage cinched tight, and your soul steady in the saddle. Because when the dust blows in and the trail gets rough, one thing keeps a rider upright: a soul sharpened by silence—and there's no better grindstone than a line shack with God waiting inside.

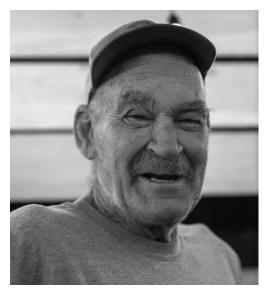
Sometimes, though, a story just has to be written.

Joey Sbragia, a man I didn't know well, but knew of and admired, passed away a few days ago.

I like to live life believing that each thing that happens to us has purpose, to take advantage of every opportunity that comes along and almost always say yes. To me, serendipity is more than a saying, it's a way of life. Serendipity, Noun: The occurrence and development of events by chance in a happy or beneficial way. "a fortunate stroke of serendipity".

However, everything has an opposite. The opposite of serendipity is Zemblanity, yes, a real word. Zemblanity, Noun: The occurrence or discovery of events described as unlucky, unpleasant or expected. The inevitable or unfortunate discovery of what one would rather not know.

On Nov. 10, 2025, we learned of the

passing of a local treasure, legend, legacy, business owner, and community leader, Joey Sbragia. This is Zemblanity.

As Serendipity plays its role, I happened to just today dig through some old Gold Hill News articles with some friends. One of those articles is the story of Joey's father "Bosso" Albert Sbragia and how he is stepping down and handing the mantle to Joey.

I hope you enjoy this story written by Jim Crandall in the Gold Hill News, Aug. 26, 1976.

Bosso Steps Down

"It is better to live one day as a lion than a hundred years as a lamb," says 64 year old Albert Sbragia, quoting Mussolini's famous line. "In this I agree one hundred per cent." Sbragia or "Bosso" is in the process of turning over the Dayton Inn to his son Joey. Sbragia built the bar in 1957 and has ruled it with an iron hand, commandeering the respect of his clientele.

Dayton Constable Rocky Adamson recalls an instance of Albert's forcefulness. "A few years back some out-of-towners were at the Dayton Inn. They were giving Albert a bad time and I think they were trying to rob him. Albert grabbed his rifle and chased them out of the bar.

"There were about four of them and when they got in their car they pulled out a pistol and shot through the front door and through the window. Albert grabbed his gun and ran right out through the door and up to the car.

"He told them 'Stick 'em up' and those guys reached for the ceiling. He blew out one of the tires and stuck the gun back in the car, and those guys reached even higher. He went around to every tire and blew them all out. By the time he was done those guys liked to have reached clean through the roof of that car. I don't think those guys ever came back to town again."

"Albert has always been the first to help somebody if they really need it," says Louie Giometti who was born and raised in Dayton. But Albert wouldn't pass a dime if he felt that a person was capable of making

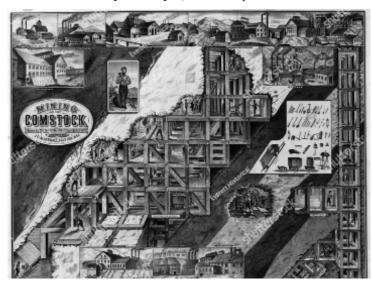

Lyon County Commissioners Vote Unanimously to Proceed with Dayton Depot Reconstruction

Dayton's residents were happy to hear that during the Aug. 21 Lyon County Board of Commissioners meeting in Yerington, the commissioners voted 5-0 in favor of allowing the rebuilding of the historic 1881 Carson and Colorado Railroad Dayton Depot and to allow the signing of the contract with the builder who has won the bidding process.

The Depot was moved from Mound House to Dayton on Railroad Street in 1881. It was later moved from Railroad Street to the empty lot at the corner of U.S. 50 and Main Street and was remodeled to become a residence around 1955. But as the years passed, building owners Chester and Helen Barton, along with the members of HSDV, decided the Depot was too historic for Nevada's railroading history to lose. Tennant Construction and Marty Banta Construction moved the Depot with house moving equipment and slowly and surely, volunteers worked, worked and worked to preserve it and it was in beautiful condition and nearly finished when the arson torched it in 2020.

Speaking for the HSDV at the Commissioners meeting, Stony Tennant, longtime local contractor and historian – who has spent unbelievable time with the Depot reconstruction itself – told the Commission that the fire insurance only pays for the rebuilding itself and once it is constructed, the HSDV will qualify for grants to get the extras. He also noted that the

building will not be in use daily until it has restrooms, electricity and fire suppression. Tennant also noted that rebuilding the Depot back to its original look of its era was of utmost importance when it comes to this project.

Many thanks to John Crowley and Dr. Linda Clements who worked and worked too with Stony Tennant on the committee to get the Depot rebuilt.

Dayton County Commissioner John Cassinelli said:

"I am looking forward to the reconstruction of the Dayton Depot and getting it listed on the National Register of Historic places. The Carson & Colorado Railroad Depot is an integral part of Dayton's and the region's history. As we continue developing this area into a historical tourism destination with sites such as the Sutro Tunnel, the Donavan Mill, and others, the Depot has much potential as a starting point for self-guided tours, and future site development including potential parking and restrooms. Many have expressed concerns that the reconstruction does not include fire sprinklers, and I understand those concerns, but folks need to understand the building really is not that large. It is 20 ft. by 60 ft. (1,200 sq.ft.) and commercial fire sprinklers are normally in structures over 5,000 sq.ft. It will be a basic square-set timber built warehouse-like structure, and will be used to store other historic artifacts, and serve as a satellite museum of sorts."

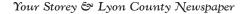

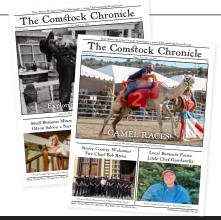
